All of the board and committee meetings this year have been conducted virtually. By doing all of this, saves the association a lot of expense, because there are no travel expenses or meal expenses incurred by board and committee members.

We have also honored our fiduciary duties to you by attending required SNA conferences and trainings virtually. The most recent national conference was LAC in DC in March. So much can be accomplished in a shorter amount of time, and this will help ensure the continuing strength and success of our association. ## **What happens if multiple nominations for office occur?**

It is possible that there are multiple nominees and the LDC will hold an interview session that will score each member and then determine the two candidates for office.

## **Can a current appointed board member run for an elected office?**

Yes, they will meet the criteria and can have their name placed on the ballot.

## **What do candidates need to run for office?**

To run for office of Vice President, Nutrition Chair and/or Secretary Treasurer:

- Member will need district approval. This is so the district understands the time commitment needed to be on the board.
- Member must sign a receipt form that they read, acknowledge MSNA's Conflict of Interest Policy, Anti-Trust Policy, Whistle Blower Policy.
- Candidate must agree to an interview prior to being placed on the ballot should the need arise due to many applicants for the same position.
- Must hold SNA certificate.
- Send in a bio and head shot for website and newsletter

## **RULES**

To be eligible to vote you must be a SNA/MSNA member in good standing as of March 30, 2021.

You must enter a valid SNA ID number to be qualified to vote.

You may only vote once.

Voting will be conducted May 1-15, 2021.

MSNA will be conducting the election through online voting, via a Survey Monkey link that will be emailed to all MSNA school members (no Industry members are eligible).

When the election opens on the morning of May 1, you should look for an email sent from Survey Monkey. If you don't receive the initial email in your inbox, first check your "spam," "clutter" and "other" folders.

If you still can't find the email? Don't give up—there are some simple steps to get what you need to participate in this important election.

It's possible you did not have a valid, individual email address in your SNA record as of March 30th or, you might have changed your email since last updating your member profile, or you might have a shared email address with other members of your cafeteria or district.

## **Here is what you can do:**

- Update your email address by visiting SNA
- Click on the red "Login to my account" button, Check that your member profile includes an accurate, individual email address that is unique to you (or your family)
- If your email address was inaccurate or missing, or if the information was correct but you still didn't receive the election email please contact the MSNA office, toll-free, 877-251-2344 or via email at [minnsna@gmail.com](mailto:minnsna@gmail.com) to assist you.

It looks like things are starting to level off a bit on the COVID pandemic. More schools now have their students in the buildings and many people have received their vaccine.

Our districts have worked tirelessly to feed the students and community and I want you to know how much I appreciate you all. I also want to

give a quick shout out to my staff for their hard work and showing up each day!!

I know many of our members are asking what is happening with the annual conference. MSNA is still working hard behind the scenes, watching what is happening with the CDC guidelines, what the state guidelines are to make sure we are understanding what the event protocol is. We need to make sure that we can have the conference safely and have the maximum number of attendees as allowed. This will help determine how MSNA will come to a decision. As treasurer, I am also working on what different type of financial scenarios would come into play for the financial piece. We must be able to sustain the costs-cover all costs-no matter what type of conference we might have.

I am closely monitoring the fiscal status of the association and we are still at minimal spending status. With the many implemented measures, we put into place to help cut costs we did have to transfer funds from our savings account to checking account. We have implemented a No travel (outstate conferences or mileage), all virtual meetings and this has helped us with our expenses. If needed, we will be able to transfer funds from the investments. As you all know, our Association has been preparing for a situation

where we would need to use the financial reserves we have in place. Thank you to the past boards that had the future of the association in mind when working to have these reserves in place!

Our accounting firm, BergenKDV, has completed the 2020 IRS tax filings, filing the renewal certificate with the MN Secretary of State (nonprofit status) and the financial audit. This information will be included in the business meeting this fall.

We have successfully concluded the online Nutrition Webinar Series. Over the last 3 months, many of our members have taken advantage of the wide variety of sessions for a very low cost. We will be working on the final review of this series and will be generating a report to the board. I want to thank all the members who attended the webinars and I want to give a very big thank you to all the presenters. You all ROCK!!

# Public Policy Update

Greetings to all!

The 2021 legislature has been running hard the last three months, hearing numerous program budget requests and policy initiatives. Education has seen no shortage of legislative requests. Legislators got to catch their breath as they took their traditional Passover/Easter break. When they returned to

business on Tuesday, April 6 they awoke to the reality that they have 6 weeks left until the constitutional end of session hits on Monday, May 17. The focus of session now turns to the major omnibus budget and policy bills and the eventual conference committee process between the House DFL majority and the Senate GOP majority. Of course, the Walz administration plays a major role in end of session negotiations as the Governor decides whether or not to sign or veto the legislation that makes it to his desk.

For our part, we've been focused on legislative conversations around "lunch shaming" and "hunger free schools." The lunch shaming legislation has been around for years (SF 777 Karin Housley/HF 149 Jurgens) and appears slated to pass into law this session, but that's been said before. The bill would require school districts to post their policies for unpaid meal debt on their websites. It would prohibit nutrition staff from taking away meals that are served to kids, regardless of the balance in their accounts. This legislation is basically a further articulation of current law which states that school shall not "demean or stigmatize" students for inadequate meal account balance.

State legislation to create "Hunger Free Schools" is an effort by Hunger Solutions and many other partner organizations, including Blue Cross/Blue Shield, General Mills, among others. MSNA has declined to sign on in direct support as we seek to learn more about how the advocates would use the Community Eligibility Program (CEP) to drive universal meals in Minnesota. MSNA has been helping our national, SNA, with their push on Congress to make universal meals a reality nationwide.

In the meantime, the state House Education committee did review an amended version of HF 1985 (Jordan, DFL Minneapolis) that would have the state provide gap funding for CEP eligible schools who aren't participating due to the economic loss the program would force on food service. MSNA's PPL Chair, Brenton Lexvold, provided passionate testimony in support of universal meals and the importance of permanently expanding the National School Lunch and School Breakfast Programs to offer all students meals at no charge as an integral part of the educational experience. He focused on kids, and the great work school nutrition programs are doing today, while noting the SNA push to make universal meals a reality, nationwide.

It will be interesting to see how the remainder of this session plays out and whether or not the House DFL majority brings funding for school nutrition programs to conference committee. The Senate GOP majority has a much smaller budget target to work with and didn't review the Hunger Free Schools proposal. As always, thank you for your work each and every day to provide kids with healthy meals.

On Wednesday, March 10th, we were able to meet with our Senators & Legislators to discuss our concerns and ask them to support the push for "Free Meals for All". We met with the following offices: Senator Amy Klobucar, Senator Tina Smith, Congress Women Betty McCullum, Angie Craig & Michelle Fischbach, Congressmen Tom Emmer, Pete Stauber, Jim Hagedorn and Dean Phillips. We were not able to secure an appointment with Rep. Ilhan Omar.



## USDA Publishes Meal Data Revealing Fewer Meals Served and Financial Loss

On March 12, the U.S. Department of Agriculture (USDA) published [new data](#) that shows school meal programs served 30% fewer breakfasts and lunches to students and incurred significant losses in federal revenue in the first nine months of the pandemic (March-September 2020), as compared to the same time period in 2019. SNA has published [an analysis](#) of this data and continues to [urge Congress](#) to provide additional relief funds to keep school meal programs financially sustainable and ensure student access to healthy school meals. Chairwoman Stabenow (D-MI) and Ranking Member Boozman (R-AR) called upon several witnesses, including SNA Public Policy and Legislation Committee members, Jessica Gould, RD, SNS, the Director of Nutrition Services at Littleton Public Schools in Colorado, and Diane Golzynski, PhD, RDN, the Director for the Office of Health and Nutrition Services for Michigan's Department of Education. During their testimony, Dr. Golzynski and Jessica Gould outlined the importance of a strong safety net
