- Knowledge of finance & budgeting

Leadership Development Committee

- Be a member in good standing for a minimum of two years preceding nomination
- Employed in an eligible field
- Retains Membership at the time of nomination

Position Descriptions

Vice President

- Perform the duties of the president-elect in the president-elect's absence.
- Serve as the liaison for association affinity groups, and other committees as needed.
- Succeed to the office of president-elect following official installation or in the event of the president-elect's death, resignation, or removal from office. If filling a vacancy for the office of president-elect, the vice president shall then continue in service and also serve the usual term as president-elect the following year.

Secretary/Treasurer

- Monitor association funds, investments, and securities, including budget preparation.
- Coordinate communications for the association.
- Serve as chair of the finance committee and on other committees as needed.

Leadership Development Committee

- The leadership development committee shall identify and recruit eligible candidates based on leadership competencies and diversity.

Happy New Year!




Wow, did not think I would be saying that already. Can you believe how time goes so fast? It seems we just started the school year and we are now halfway through.

In late November, after a few revisions, the final draft was submitted to the Executive Committee for final approval. That draft was approved and is now in place.

Public Policy Update

Did you know that MSNA is working to pass a breakfast after the bell bill? Over the past year MSNA has been working with other advocacy groups to promote breakfast after the bell legislation. While the bill has not passed in the Minnesota Legislature yet, I wanted to make sure you knew about it.

The Breakfast After the Bell bill H.F. 1037 offers schools who apply and are approved, the funding to provide a universal breakfast in their school. In our bill, a school that is at least 30% free and reduced eligible, would be able to apply to the Minnesota Department of Education to be considered. The school will need to provide documentation that their building administration supports breakfast after the bell initiatives, and that their school will offer a universal breakfast after the bell program. This is not an all or nothing program where a whole school district needs to apply. Funding will be provided on a school by school basis.

Breakfast after the bell programs can include grab and go, breakfast served in the classroom, second chance breakfast, or any other breakfast model that provides or allows all students in the school the opportunity to be served and eat a breakfast after the bell. Funding for the Breakfast After The Bell program would be provided by

the state of Minnesota. Schools would need to use all of the federal meal reimbursement funds available to them first, and then the state would cover the remaining meal costs.

For schools who are close to covering the costs of a Community Eligibility Program (CEP) the MDE would work with you to see if the additional breakfast after the bell program funds would help you cover the cost of CEP.

In the meantime MSNA will need your support to get this bill passed. Legislators will want to know from you, how your students, schools, and districts would benefit from having a breakfast after the bell program in your schools. Support for the Breakfast After the Bell legislation can be as simple as sending a note to your state representative or calling your representatives office. Others can show their support by meeting with your state representative in person, or inviting your legislator to visit your school.

Marketing Committee Update

In late November, the Marketing Committee recommended to the Board to upgrade to MemberClicks, a membership management software that would condense many of the stand-alone software that MSNA is currently utilizing. The Board approved this upgrade and the new system will be fully integrated by mid-March.

This new system will support an upgraded website that allow for a "members" only section that will enable members to login and have an online community, private networking, discussion forums (permission based) and many other tools. MSNA will be able to customize calendars, list events with details. More online registration options to promote conferences and option for group registrations from a single registrant. We will also be able to utilize email responses & receipts for events.

With this system, we will transition over to a new credit card payment system that will allow for lower fees with more secure options.

The Marketing Committee will be working on transitioning the web pages and creating new pages that will make for a more integrated administrative access and a more vibrant website for members!

Please be patient while this transition occurs. We will not have access to online registration until the new website is up & running. Until then, we will need to utilize paper forms but will have access to credit card processing.

Local Wellness Policy: Triennial Assessment Due June 30

The Child Nutrition Reauthorization Act of 2004 requires all educational entities participating in the National School Lunch Program to establish local school wellness policies. In 2010, the Healthy, Hunger-Free Kids Act (the Act) regulations added Section 9A to

expand upon the previous local wellness policy requirement from the Reauthorization.

The Act strengthens wellness policies by emphasizing ongoing implementation and assessment. This provision also supports a robust process at the community level, including the expansion of the team of collaborators participating in the wellness policy development.

Full implementation of the Wellness Policy requires the local educational agency (LEA) to inform and update the public, including parents and students, about the content and implementation of the local wellness policy. Schools typically post this information on the school or district website. LEAs are also required to measure and make available to the public periodic assessments of the local wellness policy, including:

- The extent to which schools are in compliance with the local wellness policy.
- The extent to which the LEA's local wellness policy compares to model local school wellness policies.
- The progress made in attaining the goals of the local wellness policy.

So what does this mean for LEAs and School Food Authorities (SFAs)? It means that for most schools, the first deadline for analyzing and reporting assessments will be due at the end of this school year. LEAs/SFAs are required to complete their first Local Wellness Policy triennial assessments by June 30, 2020

Background Information

An assessment of your school wellness policy must be conducted a minimum of once every three years; however, Local Educational Agencies (LEAs) may assess their policy more frequently if they wish. The results of the assessment must be made available to the public.

Purpose

The template below is offered as a way to summarize the information gathered during your assessment. Members of a school wellness committee who are completing their triennial assessment for their school wellness policy may use the template provided on the MDS website (are indi-

cated below). It contains the three required components of the triennial assessment,

Results

The copy of the assessment must be made available to the public. How the assessment is made available is the decision of the LEA. Many LEA's choose to post the results on their district website. The triennial assessment summary and the assessment details (e.g. WellSAT 3.0 report) must be shared.

Recordkeeping

Keep a copy of the most recent triennial assessment, along with supporting documentation on file. This will be needed when you have a School Nutrition Program administrative review.

SNA Launches Research Initiative on Universal Meals

Studies have shown that school meals contribute to the health, attentiveness, behavior and academic achievement of students. SNA [believes](#) all students should have equal access to nutritious school meals, and that is why we are excited to announce a new research initiative that will evaluate the potential social benefits and costs of expanding the National School Lunch and Breakfast Programs, to serve all students at no charge.

School meals not only ensure students have the nutrition they need throughout the day to learn, but they also play an important role in supporting obesity prevention and improving children's diets and health outcomes. Previous studies on universal meal proposals have focused on the price tag, without quantifying and comparing the many long-term benefits of increased student lunch and breakfast participation.

To support SNA's advocacy efforts with Congress and the Administration, SNA's Board of Directors approved funding for an independent research firm specializing in regulatory advocacy and economic analysis to conduct a benefit-cost study of a universal school lunch and breakfast program. The firm chosen has significant Office of Management and Budget (OMB) and Office of Information and Regulatory Affairs (OIRA) experience and will provide a thorough, OMB-compliant economic analysis of the social benefits and costs of creating a universal meals program. This research effort will focus on the National School Lunch and Breakfast Programs. SNA will keep you posted on the outcomes of the analysis.

USDA Releases Updated Guidance for Unanticipated School Closures

The U.S. Department of Agriculture's (USDA) Food and Nutrition Service (FNS) released [updated guidance](#) on meal service during unanticipated school closures. School Food Authorities (SFAs) participating in the National School Lunch Program and/or the School Breakfast Program, institutions participating in the Child and Adult Care Food Program (CACFP), and sponsors participating in the Summer Food Service Program (SFSP) are encouraged to use the flexibilities described in this memorandum to help ensure that children do not experience a lapse in food security when extreme weather or other events force area schools and child-care facilities to close.

Serving Pre-K Meal Patterns Update

Do you serve preschool students?

If so, you are required to serve their meals according to the preschool meal pattern if they are served separately from older students (i.e., K-5 students). Here are some ways the preschool meal pattern differs from the K-5 meal pattern:

- Preschool students are not allowed to be served flavored milk.
- Grain-based desserts are not creditable for preschool students.
- The daily portion requirement for meat/meat alternate for preschool students at lunch is 1.5-ounce equivalents.
